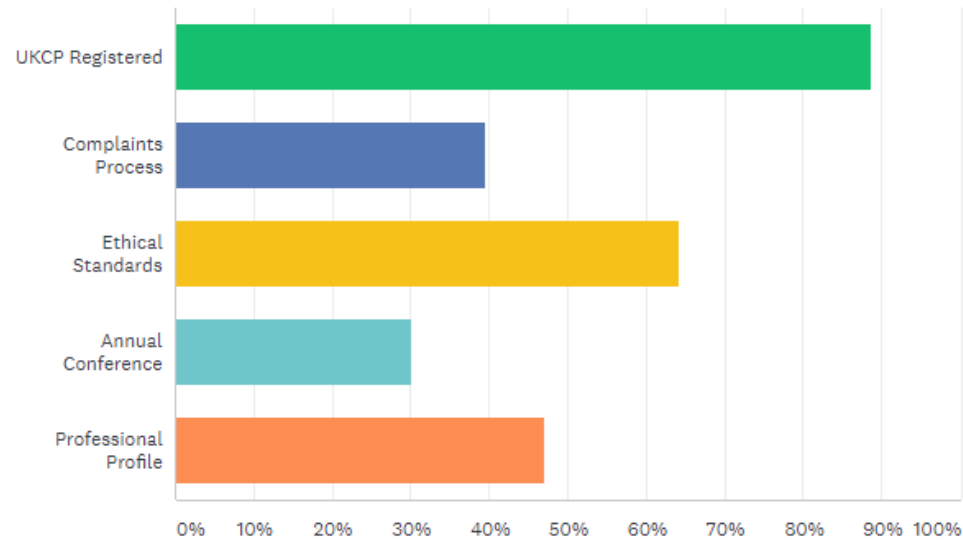

More high profile and acceptance of NLP in the therapeutic community

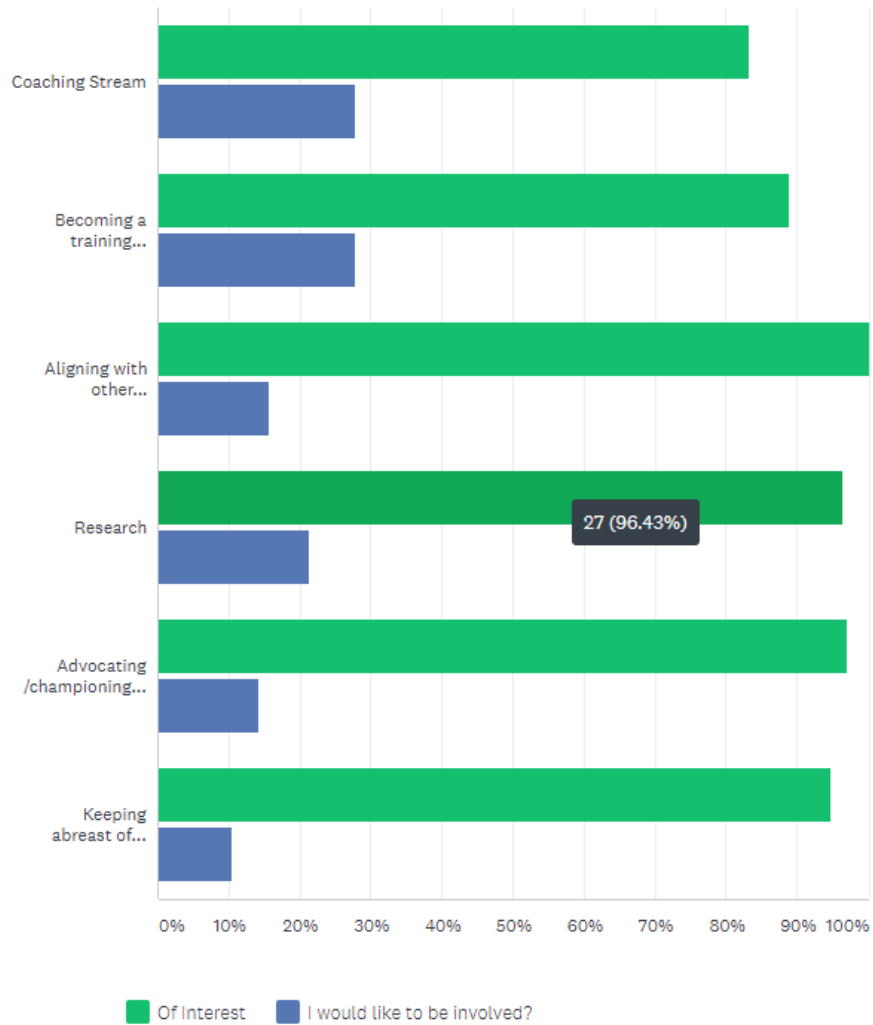

It would depend on what my client would want.
Grow the modality, maybe link with the symbolic modelling trainings, find a way to encourage therapists through from NLP trainings.
Run CPD introductory workshops introducing the key concepts in attachment theory, somatic experiencing and constellation therapy in the interests of broadening NLPt scope of practice
Just keep doing what you are doing. I appreciate you are all volunteering in your posts.
Have an open mind on all therapeutic modalities not just NLP
For therapists who have been registered over 10 years I think a more streamlined re-application every year would be sensible.
Be as involved in personal change as it's membership
Be a bit more proactive in promoting NLPt psychotherapy and directory listing of services
More modelling, use the meta research into what works in change work as a meta model IE Bergin and Garfield's Handbook of Psychotherapy and Behaviour Change Book by Michael J. Lambert and Scott Miller's work derived from this as a way of framing what we do. Thus showing that we do is extraordinarily well researched and the World owes us a living. Oh and more of an emphasis on modelling.
Acknowledge that members who have been re-accredited over 20 times have proved their trustworthiness and do not require to go through the process every single year.
Publish articles and research in variety of related publications; have presence and lobby on government policy and relevant national bodies; provide support for complaints; promote ethical practice and standards; keep NLPt alive
Be unobtrusively interested in the work of colleagues...share experiences in a professional fashion....not facebook, twitter and other
I am really pleased with what the organisation does and don't really have any criticisms

Promote the benefits of NLPt have a clear pathway for future NLPt psychotherapists have up to date research on NLPt
To connect with other psychotherapists within a networking group, and to meet on monthly basis or every 3 month basis.
To broaden the way it thinks about and talks about NLP-based therapeutic interventions, set some goals around growth and development of the NLP-based therapy community, and engage the wider NLP world around its goals for the reach and impact of NLP-based therapeutic practice
Create more webinars for CPD, have dialogue via the website, and special interest groups
Be more proactive in raising the profile of NLPt as a therapy.
I think it is doing well considering how small we are. I'd like us to find a way to be bigger. have more NLP therapists.
If possible given the resources, Advocating /championing the use of NLPt in the UK, eg via NHS, and media
The annual re accreditation is onerous and out of step with the professional organisations of my colleagues that I witness. Yet having said that I believe the standard is high and I believe this a choice you have the right to make.
If numbers shrink further to be absorbed into another college
Great consideration to older 'semi-retired' members i.e. the acceptance by the organisation that such members work fewer hours.
It would be helpful if... we, as members, found a way to create a sense of unity for ourselves that is projected into the outside world so that others see us as united and still able to hold challenge and dissent within the organisation. (are you going to ask me how? oops!) It would be helpful if ... we were very clear about (at least) a few points of common practice that defines (and is measurable) what you get if you go to an NLPt psychotherapist because I think this might help NLPtCA provide good evidence based research to show the effectiveness of NLPt to the NHS (amongst possible other commissioners).
More attention to needs of retired members and for members with disabilities
More contact with members that would contribute to CPD
I think NLPtCA used to give official post nominal letters upon registration. That'd be nice.
Wider advertisement of therapists register
Add value/generate leads

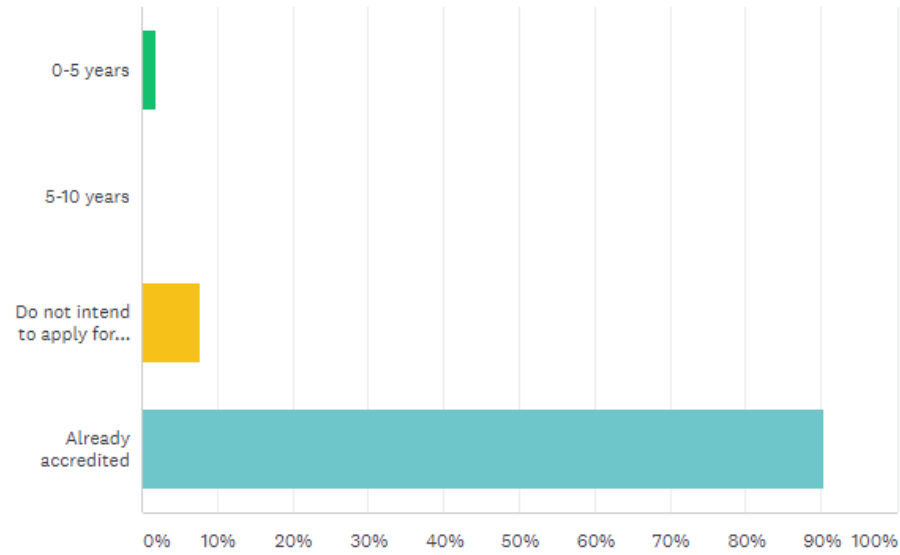

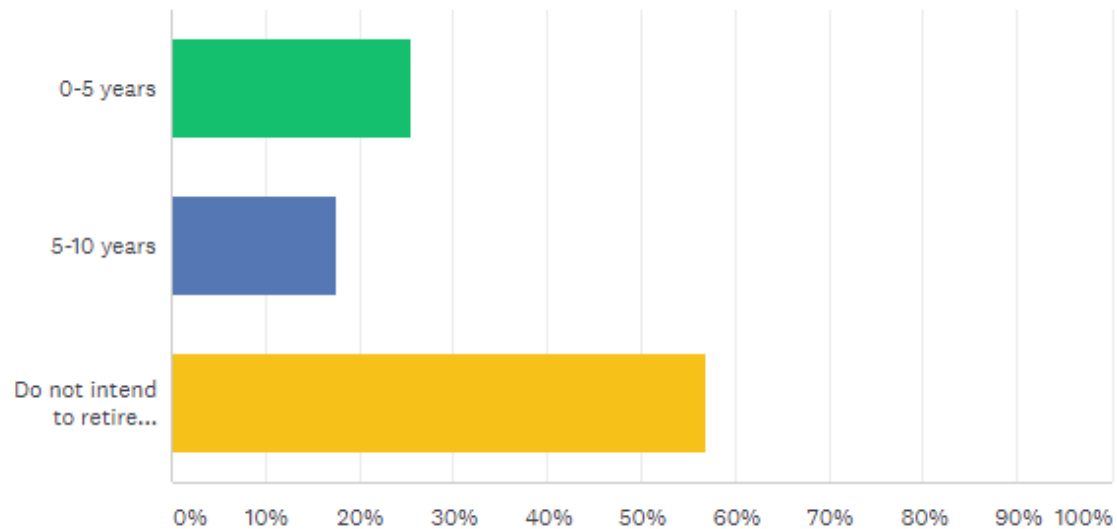
